# **PUBLIC UTILITIES**

Each person, firm, or corporation operating a public utility other than telephone, telegraph, express companies, railroad and sleeping car companies but specifically including electric light or power plants and water works, three (3) per cent of its gross income in the corporate limits of the City of Andalusia and in addition one (1) percent of its gross income outside the corporate limits but within the police jurisdiction of the City of Andalusia received during the calendar year preceding the current license year and derived from the consumer users or distributors, within the City of Andalusia, or its police jurisdiction. The application for such license shall be accompanied by a statement made by the president or manager of such public utility, giving name of the person, firm or corporation owning and operating same together with a statement under oath of the amount of the gross receipts of such public utility in the corporate limits of the City of Andalusia and its police jurisdiction during the preceding year, and the City reserves the right to have its own auditors verify the figures given in the statement.
