| 1. Rolling Stores Retailing - each person operating what is known as a rolling store and selling at retail there from | \$ 30.00 |
| 2. Power Company & Public Utilities – each person, firm, or corporation operating a public utility such as an electric light or power plant interurban or street railway operated by electricity or other motive power, gas plant, other public utility, except those licensed or exempted by law, and except as may be operated by the state and its institutions, and by the Town shall pay a privilege license of 3% of its annual gross receipts and a license of 1 ½% of its annual gross receipts within the police jurisdiction of said Town | |
| 3. Railroad – for each railroad maintaining an office in the Town used in the business of transporting freight or passengers to and from other points in Alabama | \$ 10.00 |
| 4. Express Company – each express company having an office in the town for the privilege of doing intrastate business in said Town | \$ 2.50 |
| 5. Telephone Companies – for each telephone company providing local and long distance connections between the Town of Billingsley and other points in Alabama | \$ 15.00 local

| 7. Gas Station – each dealer selling gas at retail | \$ 10.00 |

| 8. Barber or Beauty Shop – each chair | \$ 10.00 |
| 9. Taxi or Buses – each person, firm or corporation operating a car or bus for hire whether or not operating a terminal station, depot or waiting room within the corporate limits of the Town of Billingsley | \$ 10.00 |

| 10. | Fertilizer and Seed Dealers | \$ 10.00 |
| 11. | Wholesale Gasoline and Oil – wholesaling gasoline or oil from trucks or other vehicles | \$100.00 |
| 12. | Wholesale Bottling Companies – each person, firm or corporation distributing, delivering, selling or handling bottled drinks at wholesale | \$100.00 |
| 13. | Wholesale Vendors – hardware, groceries, notions, candy, drugs, produce, tobacco products, bread, ice cream, or any other articles where orders are taken, delivered, or sold to merchants from any vehicle | \$100.00 |
| 14. | Automobile Mechanics, Garage or Peddling – each person engaged in automobile, motor truck or other motor vehicle repair business | \$100.00 |
| 15. | Automobile Dealers – new or used vehicles | \$100.00 |
| 16. | Peddlers to Consumers – each person other than a merchant who pays privilege license or who shall offer for sale any produce, drugs, medicines, ointment or medical preparation or any person other than a farmer who has raised or grown the merchandise being sold | \$ 15.00 |
| 17. | Junk Dealers – each junk dealer or buyer of scrap iron, copper or other metal or other articles designed as scrap | \$ 10.00 |
| 18. | Dry Cleaning and Laundry – for soliciting or picking up laundry and dry cleaning | \$ 10.00 |
| 19. | Insurance Companies including Life and Burial – each insurance company other than fire, marine and fraternal, \$10.00 plus one dollar on each one hundred dollars and major fraction thereof of gross premium less return premiums, received during the preceding year on policies issued during said year to citizens and residents of the Town of Billingsley, and one-half of this amount for policies issued within the police jurisdiction of said town | |
| 20. | Insurance Companies including Fire and Marine – each fire and marine insurance company, \$4.00 dollars on each one hundred dollars or major fraction thereof of gross premium, less returned premiums received on policies issued during the preceding year on property located in the Town of Billingsley, and one-half of this amount for companies doing business within the police jurisdiction of the Town of Billingsley provided, that new companies shall pay a flat minimum license of \$15.00 on which there shall be an adjustment on the above basis at the expiration of the year. | |

21. Western Union or any Telegraph Company – for each commercial telegraph company having an office in the Town of Billingsley, per year	\$ 5.00
22. Butane, Propane and other Liquefied Gas Dealers – each person, firm, or other corporation delivering from truck or otherwise; wholesale or retail	\$100.00
23. Garbage Pickup – each person or company operating a garbage collection on a daily, weekly or monthly basis in the Town of Billingsley or within the Town police jurisdiction	\$100.00
24. Wholesalers for off premise beer license wholesaling beer from trucks or other vehicles	\$ 75.00
25. Retailers for off premise beer license	\$100.00
26. Video and game rooms with 1 to 20 machines. This includes store license fee and fees for machines \$10.00 for the room and \$40.00 for the games	\$ 50.00
27. Video and game rooms with 21 to 40 machines \$20.00 for the room and \$80.00 for the machines	\$100.00
28. Exterminating services	\$100.00
29. Tanning bed	\$100.00
30. Septic tank services	\$100.00
31. Satellite Telecommunications	\$100.00

Be it ordained by the Town Council that any person, firm or corporation doing business in the Town of Billingsley as listed herein must pay a license to the Town of Billingsley in the amount named herein.

Farmers selling produce or anything raised or produced on the farm are exempt from this ordinance unless bought for resale.

Any person, firm or corporation found guilty of violating this ordinance shall upon conviction be fined not less than one nor more than fifty dollars; and each day's business will constitute a separate offense at the discretion of the court.

These licenses are due January 1st of each year and must be paid on or before February 1st or a 10% fee will be added.
