Amendment to Ordinance 76-8, Section 19-61 – 19-80

Whereas the State of Alabama has passed the Alabama Business Reform Act of 2006 requiring all municipalities to adhere to a statewide standard of levying business license fees from the business community;

Where the Town of Brantley has previously passed Ordinance 76-8, Sections 19-61 – 19-80 establishing codes and rates for collecting business licenses;

Whereas the Town of Brantley has modified its rate codes and descriptions to match the NAICS codes as required by the Act:

Therefore be it ordained that Ordinance 76-8, Sections 19-61 – 19-80 be amended with the new codes and descriptions, and all other changes as required by the Municipal Business License Reform Act of 2006.

ARTICLE V. Licenses.

Sec. 19-61. Levy.

There is hereby levied a privilege license tax which shall be required to be paid by each person, firm, company, association, agency, or corporation engaged in carrying on any business, trade, profession, or calling or the doing of any act herein specified within the corporate limits of the City or within its police jurisdiction. Upon payment of the appropriate fee, the City Clerk shall issue a license in the manner hereinafter outlined in this article.

Sec. 19-62. License year specified.

The license year of the city shall begin on the first day of January of each year, and shall end on the thirty-first (31st) day of December of each year; and each license issued under the authority of this chapter whether issued on or after the first day of January of the year for which it is issued, shall expire on the thirty-first (31st) day of December of that year.

Sec. 19-63. Engaging in business without license prohibited.

It shall be unlawful for any person, firm, company, association, agency, or corporation to engage in or carry on any business or do any act within the corporate limits or within the police jurisdiction of the city for which a license is required by this chapter without first having paid for and taken out such license as herein provided, and any person violating the provisions of this article shall, upon conviction, be fined the sum of not exceeding one hundred (\$100.00) Dollars for each day so in default and may also be imprisoned in the city jail for a period not to exceed six (6) months.

Sec. 19-64. Payment of tax, issuance of license, contents, transferability; scope.

Before a person, firm, company, association, agency, or corporation shall engage in or carry on any business or do any act within the corporate limits or within the police jurisdiction of the city for which a license is required by this chapter, he, they or it shall pay to the city clerk the amount required for such license. Upon such payment, the city clerk will issue the license, which shall be signed by him as clerk and which shall set forth the name of the person, firm, company, association, agency, or corporation applying thereof, the business or act which is proposed to be carried on or done thereunder, the amount paid for such license and the time for which it is issued and the place of location of such business, and such license shall not be transferrable nor shall it entitle the holder thereof to carry on any other act than that named therein.

Sec.19-65. Duration; payments for less than one year.

Except as herein provided, all license issued under the authority of this article shall be issued for one year, provided however, that any license issued after the first day of July of the year which it is issued may be issued upon the payment of one-half (½) of the annual license, except as otherwise specified under certain subjects.

Sec. 19-66. Records of clerk.

It shall be the duty of the clerk of the city to keep a full list of all the persons, firms, companies, associations, agencies, or corporations doing business in the city and within the police jurisdiction and subject to a license, and to enter all amounts collected for licenses in a well preserved book kept for that purpose.

Sec. 19-67. Amount of license when not specified.

On any business, occupation or profession not specified in this chapter, the mayor and the city clerk jointly are hereby authorized and empowered to fix such license as may be just and proper and report the same to the next meeting of the city council for such action as the city council may deem proper.

Sec. 19-68. When due and delinquent; delinquency penalty.

All licenses payable hereunder shall be due on January first (1st) each year and shall be for one year ending December thirty-first (31st) following and shall be delinquent on the last day of February each year, provided the person, firm, company, association, agency, or corporation is engaged in such business or calling or is doing the act for which the license is required on that day, otherwise to become due on the day the person, firm, company, association, agency, or corporation engages in the business, trade or calling or does the act for which a license is required and delinquent 30 days thereafter. Where any license shall be delinquent the same shall be subject to a penalty of ten percent (10%) of the amount of the license, which penalty must be collected by the city clerk when the license is issued.

Sec. 19-69. Charge for license in police jurisdiction.

All persons, firms, companies, associations, agencies, or corporations engaged in carrying on any business, trade, profession or calling or doing any act herein specified without the corporate limits of the city but within the police jurisdiction thereof, shall be required to pay a license equal to one-half (½) the sum hereinafter specified to be charged for the same business or profession or trade within the corporate limits, fees and penalties excluded.

Sec. 19-70. Schedule of fees.

The licenses which shall be required of all persons, firms, companies, associations, agencies, and corporations engaged in carrying on any business, trade, profession or calling or doing any act herein specified within the corporate limits of the city (or within the police jurisdiction of the city as herein above provided in section 19-69) which shall be paid for the use of the city are as set forth in this section.
