AN ORDINANCE TO AMEND ORDINANCE NO 10 OF THE  
TOWN OF DAUPHIN ISLAND, ALABAMA, RELATING TO BUSINESS AND PROFESSIONAL LICENSES AND  
REPEALING ORDINANCE NO. 10K

BE IT ORDAINED by the Town Council of the Town of Dauphin Island, Alabama, as follows:

ORDINANCE NO. 10 K Section 13, Licenses and amounts thereof, is hereby amended in its entirety by substituting in lieu thereof the following:

Section 13: Licenses and Amounts Thereof:

THE ANNUAL LICENSE is hereby fixed at the amount indicated:

- A. Alcoholic Beverages: (liquor, beer, malt or brewed beverages, wine) Licenses levied under this section are in addition to all other licenses.
  - a) On/off premises less than \$50,000 per year gross.....\$125.00
  - b) On/off premises over \$50,000 to \$99,999 per year gross .....\$175.00
  - c) On/off premises over \$100,000 per year gross.....\$275.00
  
- B. Contractors and Subcontractors:
  - Contractors-Builders
    - a) Less than \$100,000 per year gross.....\$125.00
    - b) Over \$100,000 to \$249,99 per year gross.....\$200.00
    - c) Over \$250,000 per year gross.....\$275.00
  
  - Contractors-Sub (electrical, plumbing, painting, plastering, roofing, tile setting, glazing, tree surgeons, foundations, piling, mechanical, alarm installation, siding, paving, insulation, excavation, sheet rock, fence, flooring, masonry, brick, block, stucco, framer, cabinet, concrete, land fill and surveying)
    - a) Less than \$50,000 per year gross.....\$125.00
    - b) Over \$50,000 to \$124,999 per year gross.....\$175.00
    - c) Over \$125,000 per year gross.....\$200.00
  
- C. Merchants: Retail and wholesale, dealers, distributors, private clubs
  - a) Less than \$50,000 per year gross.....\$125.00
  - b) Over \$50,000 to \$149,999 per year gross.....\$200.00
  - c) Over \$150,000 to \$499,999 per year gross.....\$275.00
  - d) Over \$500,000 per year gross.....\$375.00
  
- D. Manufacturing or other related industrial operations.....\$125.00

E.	Professional: Physicians, surgeons, attorneys, accountants, engineers	
a)	Less than \$50,000 per year gross.....	\$125.00

a)	Less than \$50,000 per year gross.....	\$125.00
b)	Less Over \$50,000 to \$99,999 per year gross.....	\$150.00
c)	Over \$100,000 per year gross.....	\$275.00

H.	Vending Machine: To include vending of merchandise amusement or music, excepting coin operated laundry equipment which is licensed under Section G above.

J.	Financial Institution: Credit Union, banks	
a)	Less than \$50,000 per year gross.....	\$150.00

K.	Restaurant/Lounge/Bakery/Café'	
a)	Less than \$75,000 per year gross.....	\$125.00
b)	Over \$75,000 to \$124,999 per year gross.....	\$175.00
c)	Over \$125,000 per year gross.....	\$225.00

- L. Other: All other persons, partnerships, corporations, businesses, occupation's trades and professions, retail sale of fuel, not otherwise specified

- a) Less than \$75,000 per year gross.....\$125.00
  - b) Over \$75,000 to \$149,999 per year gross.....\$150.00
  - c) Over \$150,000 per year gross.....\$225.00

M. An issuance fee of \$10 will be collected on all Business Licenses except those listed under H. Vending Machine.

Pursuant to Ordinance 10, Section 7 (Multiple Licenses Required) adopted by Town Council on September 20, 1988 separate Licenses are required for each business for which a business is engaged.

This schedule shall be effective as of November 20, 2013.
