If you are filing less than \$200
 per quarter, you may qualify to
 file your taxes quarterly.
 To request a filing frequency
 change, submit your request *in
 writing* to the remittance
 address listed below.

Penalties are Costly!

To Avoid Expensive
 Penalties, your return must
 be postmarked by the US
 Postal Service **on or before
 the 20th of the month.** The
 penalty for failure to Timely
 File is \$50 or 10% of the tax
 due, whichever is greater.
 The Penalty for Failure to
 Timely Pay is 10% of the tax
 due. Please note that the
 penalties are *per jurisdiction.*
