**Do You Qualify
for Quarterly Filing?**

Do you file less than \$200 per quarter? You may qualify to file your taxes quarterly. To request a filing frequency change, submit your request **in writing** to the remittance address below.

Penalties are Costly

To avoid penalties, all returns must be postmarked by the US Postal Service **on or before the 20th of the month**. The penalty for Failure to Timely File is \$50 or 10% of the tax due, whichever is greater. The penalty for Failure to Timely Pay is 10% of the tax due. Please note that the penalties are per jurisdiction.

Business License Due Date

Business licenses for Alabama municipalities were due January 1, 2012. Licenses purchased on or after February 1, 2012 are now considered late, unless the municipality has extended the delinquent date via business license ordinance.

Cities and Counties Receive Smart Government Award

The Smart Government Awards were developed by RDS to recognize innovative governments and efficient programs in Alabama. The awards identify local governments that are taking innovative steps to enhance growth, create cost savings and provide environmental benefits.

City of Vestavia Hills

The City of Vestavia Hills received the Smart Government Award for providing the state's first Leadership in Energy and Environmental Design (LEED)-certified public library. In response to a long-range strategic plan in advance of the city's projected population growth, the Vestavia Hills Mayor and City Council identified the current library as an inadequate public facility. In response, the mayor and council authorized a \$4 million challenge-grant to the private sector that would be matched dollar for dollar by the city to fund the state-of-the-art library project.

City of Bayou La Batre

Described as the "Seafood Capital of Alabama," the small coastal city of Bayou La Batre has taken many steps to create financial stability while reducing the total energy demand for the city. The city has demonstrated its concern for the environment by creating a city-managed, efficient, solid waste collection and disposal program. The city also instituted a four-day work week and, with funding partially provided by energy conservation grant funds from the State of

Alabama, will soon retro-fit the HVAC system at the 12,000-square-foot BLB Community Center.

City of Guntersville

The city expanded recycling collection efforts, implemented "paperless" practices in the police department, and motivated community members to contribute to litter prevention among other cleanup efforts. Existing environmental efforts were further enhanced in a cost effective manner through revised procedures and practices. The city also stepped up efforts with the "Recycling Away From Home" program by incorporating recycling containers into the Downtown Streetscape Renovation.

Limestone County

The 39th District Court and Limestone County Jail now utilizes video and document management technology to conduct remote electronic hearings, a practice that eliminates the need for transport of prisoners to hearings and reduces manpower and transportation costs to the county.
