To avoid penalties, all returns must be postmarked by the USPS **on or before the 20<sup>th</sup> of the month**. The penalty for Failure to Timely File is \$50 or 10% of the tax due, whichever is greater. The penalty for Failure to Timely Pay is 10% of the tax due. Please note that the penalties are per jurisdiction.
