**Sales/Use increase**

Online filing is available for Sales, Use, Rental and Lodging tax. Payment can be made via Credit Card, ACH debit and paper check.

#### Penalties are Costly

To avoid penalties, all returns must be postmarked by the US Postal Service **on or before the 20<sup>th</sup> of the month**. The penalty for Failure to Timely File is \$50 or 10% of the tax due, whichever is greater. The penalty for Failure to Timely Pay is 10% of the tax due. Please note that the penalties are per jurisdiction.
