 Effective April 2016 taxes due on or before May 20th  
 (See rate sheet for all rates)

**New Admin Lodging Tax**  
**General Lodging** 6%  
**Plus \$2.00 surcharge per room, per night**  
 Effective April 2016 taxes due on or before May 20th

**Lodging** 7%  
 Effective May 1, 2016, taxes due on or before June 20th

 Effective May 2016 taxes due on or before June 20th

**Penalties are Costly**

To avoid penalties, all returns must be postmarked by the US Postal Service **on or before the 20<sup>th</sup> of the month**. The penalty for Failure to Timely File is \$50 or 10% of the tax due, whichever is greater. The penalty for Failure to Timely Pay is 10% of the tax due. Please note that the penalties are per jurisdiction.
