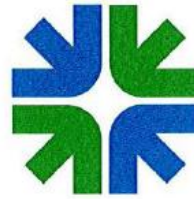

**\*\*IMPORTANT UTILITY USERS TAX INFORMATION FOR THE CITY OF EMERYVILLE \*\***

The City of Emeryville has chosen MuniServices, LLC to assist the City's staff in the collection of the Utility Users Tax. Service Providers will begin filing their Utility Users Tax returns and remitting tax payments to MuniServices on behalf of the City of Emeryville beginning with **tax period July 2013. (Taxes due on or before August 20<sup>th</sup>)**

For your convenience, we have enclosed three customized remittance forms from MuniServices, LLC. The MuniServices form should be completed and remitted along with your tax payment each month beginning with tax period July 2013. You may make copies as needed. As an added convenience, **online filing will also be available for the City of Emeryville beginning August 1<sup>st</sup>** at [www.salestaxonline.com](http://www.salestaxonline.com) with the ability to pay via ACH Debit. Coming Soon: Credit Cards! The online filing link and downloadable forms are also available on the MuniServices website at [www.revds.com](http://www.revds.com).

**Please note that payments and correspondence for the City of Emeryville Utility Users Tax must be sent to the MuniServices address listed below effective tax period July 2013.** Failure to use the MuniServices, LLC forms or online filing may result in an unnecessary delinquency notification. As a reminder, the City of Emeryville Utility Users Tax is **due on or before the 20<sup>th</sup> day of the month** for the preceding month's taxes. Please review the customized forms upon receipt and contact MuniServices immediately if any changes to your account information need to be made. This will ensure timely receipt of your payment and avoid any misguided notifications.

Please update your accounting system and/or notify your business' tax preparer to mail all Utility Users Tax remittances and correspondence for the City of Emeryville to the following address effective tax period July 2013 (due on or before August 20<sup>th</sup>):
