Your annual Beer and or Liquor Licenses are due on or before December 31<sup>st</sup>. Your remittance should be submitted along with a signed copy of this form for the purpose of obtaining your annual Village Beer and or Liquor License. Your current license expired at MIDNIGHT ON December 31<sup>st</sup>. If you wish to operate after midnight, you must have your renewal license.

## HIGH ALCOHOLIC CONTENT BEVERAGES:

### CLASS A LICENSE:

In every business conducted in the Village of Richmond at a bar room, cabaret, coffee house, liquor exchange, drinking saloon, grog shop, or other places where spirituous vinous alcoholic liquors or intoxicating beverages of any kind are sold directly or indirectly in quantities of less than five gallons and in broken packages by the drink, the seller thereof shall pay an annual Village License of **Five Hundred Dollars (\$500.00)**.

### CLASS B LICENSE:

In every business conducted in the Village of Richmond at a bar room, cabaret, coffee house, liquor exchange, drinking saloon, grog shop, or other places where spirituous vinous alcoholic liquors or intoxicating beverages of any kind are sold directly or indirectly in packages of not less than or one-half (1/2) of one pint contents, the seller thereof shall pay an annual Village License of **Two Hundred Fifty Dollars (\$250.00)**.

## LOW ALCOHOLIC CONTENT BEVERAGES:

**WHOLESALESALEERS: Five Hundred Dollars (\$500.00)**

**RETAILERS CLASS A:** Authorizes the retailer to sell for consumption on or off the licensed premises – **Thirty Dollars (\$30.00)**

**RETAILERS CLASS B:** Authorizes the retailer to sell in sealed containers prepared for transportation and consumption off premises – **Twenty Dollars (\$20.00)**
