If gross receipts exceed \$100,000.00 then an additional fee is due based upon an increment scale as noted above.

All NEW businesses located inside the city limits of the City of Seaside are required to pay a Fire Inspection Fee of \$252.00, in addition to the Admin Fee and License Fee. All new businesses located inside the city limits of Seaside will require city approval prior to the issuance of a business license.
