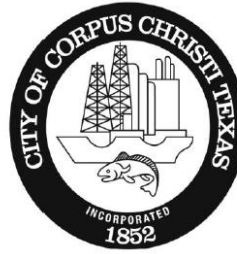

****IMPORTANT HOTEL OCCUPANCY TAX INFORMATION FOR THE CITY OF CORPUS CHRISTI ****

The City of Corpus Christi has chosen MuniServices, LLC to assist the City's staff in the collection of the Hotel Occupancy Tax. Businesses will begin filing their Hotel Occupancy tax returns and remitting tax payments to MuniServices on behalf of the City of Corpus Christi beginning with tax period October 2012. (Taxes due on or before November 30th)

For your convenience, we have enclosed one customized remittance form from MuniServices, LLC. This form should be completed and remitted along with your tax payments each month beginning with tax period October 2012. You may make copies as needed. **Online filing is also available at www.salestaxonline.com.**

Please note that payments and correspondence for the City of Corpus Christi Hotel Occupancy Tax must be sent to the MuniServices address listed below effective tax period October 2012. Failure to use the MuniServices, LLC forms or online filing may result in an unnecessary delinquency notification. Please review the customized form upon receipt and contact our office immediately if any changes to your account information need to be made. This will ensure timely receipt of your payment and avoid any misguided notifications. **As a reminder, the City of Corpus Christi hotel occupancy tax is due on or before the last day of the month following each monthly period.**

Please update your accounting system and/or notify your business' tax preparer to mail all Hotel Occupancy Tax remittances and correspondence for the City of Corpus Christi to the following address effective tax period October 2012 (due on or before November 30th):
